Innovative VET provider Award for the European Vocational Skills Week 2019

This award aims to identify a European organisation, provider of Vocational Education and Training (VET provider) that has contributed to VET excellence through innovative practices.

The European VET provider must showcase innovation and inspire other VET providers to create excellence in VET, making learners, trainers, companies and society all winners.

The award is organised by the European Commission, in cooperation with the expert group "Platform of European Associations of VET Providers".

1. Eligibility of VET providers

The award is open to public and private VET providers that fulfil the following requirements:

- Their predominant activity is to deliver initial or continued VET
- The education and training delivered addresses young people and/or adults
- They are established in an EU Members State, a Candidate or an EFTA Country.

2. Selection criteria:

The following criteria apply for this award:

- 1. The VET provider has relevant accreditations, certification or has received previous awards
- 2. The VET provider delivers a new and innovative approach to learning that by its implementation shows a higher speed or quality of acquirement of knowledge, skills or competences in the context of an educational program.
- 3. The approach is based on educational research findings and/or practical experience; strategic and operational links with research institutions or partnerships, including companies, are particularly welcome.
- 4. The VET provider's approach should demonstrate proven benefits, in a holistic manner, i.e. for learners, employment, companies, society.
- 5. The provider's approach should demonstrate being attractive for learners, including their families, and reducing drop outs, also benefiting learners at risk, those with special needs, NEETS, migrants and other disadvantaged groups.
- 6. The provider's approach is aimed at and shows effects for employability; the latter is ideally proven by tools and systems for tracking employability (for both young learners and adults).
- 7. The provider implements state of the art technology (4.0, simulators, ICT enhanced learning, other digital tools, etc.).

The criteria are cumulative. This means that, on the basis of the presented evidence, the nominees will be the providers that meet a maximum of the above criteria best. So, the VET provider does not need to meet all the criteria, but the more criteria the VET provider meets, the better the chances to be selected.

The jury will select the two best applications and these 2 nominees will be invited on 17-18 October 2019 to Helsinki for an evening Award Nominees Celebration.

The public (through on-line voting) will be able to choose from the two best applicants their favourite one, in the Autumn.

On 17-18 October in Helsinki Ms. Marianne Thyssen the Commissioner for Employment, Social Affairs, Skills and Labour Mobility will announce the winner (as a result of combined votes of the Jury and the on-line voting by the public)

3. Evaluation Committee

An Evaluation Committee will be created among members of the "Platform of European Associations of VET Providers".

Depending on the number of applications to be assessed, sub-juries can be installed, each dealing with a part of the applications. The final decision will be made by the main jury.

No members of the jury will themselves nominate and/or are involved in direct nominations of providers by their association. If the institution of any of the jury members applies, the jury member will be replaced by another member of the association.

4. Additional information

Deadline for applications is **10 June** . The name of the nominees will be communicated in September/October.

Two nominees will be invited to Helsinki, Finland on 17-18 October 2019. Travel and accommodation to participate in the ceremony will be covered by the European Commission. No information will be communicated about the unsuccessful candidates.

Award for VET teachers and/or trainers European Vocational Skills Week 2019

This award aims to identify a Vocational Education and Training (VET) teacher and/or trainer that has contributed to VET excellence through his/her personal and professional way of interacting with learners.

The award is organised by the European Commission, in cooperation with the expert group "Platform of European Associations of VET Providers", Obessu and ETUCE.

1. Eligibility of VET teachers and trainers

The award is open to VET teachers and trainers that fulfil the following requirements:

- They work in direct contact with learners in initial or continued VET
- They have obtained a written recognition/prize/award at their name as teacher or trainer in their country, by a public or private body after 01.01.2016
- Applicants are resident in an EU Members State, a Candidate or an EFTA Country.

Teachers and trainers can apply themselves or be nominated by an organisation. In case an organisation is supporting their nomination, a recommendation letter can be uploaded in the application site (see under point 5)

2. Selection criteria:

The following criteria apply for this award:

The teacher and/or trainer:

- 1. Shows great results in **student-centered teaching** and a personal and professional way of **motivating** learners to try and get the best out of their education / reach a maximum progression, including those with special needs
- 2. Shows a creative, innovative and consistent style in transferring knowledge and skills
- 3. Uses **innovative learning environments**, including digital ones (ex: e-learning, web learning, gaming, videos, tutorials, social networks, etc)
- 4. **Encourages learners** to learn for their life, employability and professional development, and first and foremost following their own interest and reach curricular requirements.
- 5. Is enthusiastic towards his/her profession or subject he/she teaches/ trains on.
- 6. **Collaborates and engages** to other teachers, trainers, and with possible local actors, including companies and training centers (peer learning)
- 7. Keeps his/her knowledge updated on pedagogic and professional developments
- 8. Stimulates the focus of **practical learning** within schools and companies, as well as with the local community.

The criteria are cumulative. This means that, on the basis of the presented evidence, the nominees will be the individuals that meet a maximum of the above criteria best. So, the applicant does not need to meet all the criteria, but the more criteria he/she meets, the better the chances to be selected.

The jury will select the two best applications and these 2 nominees will be invited on 17-18 October 2019 for an Award Nominees Celebration.

The jury reserves the right to award also a special selection of the Jury, in case this is found appropriate.

The public (through on-line voting) will be able to choose from the two best applicants their favourite one in the Autumn

On 17-18 October 2019 Ms. Marianne Thyssen the Commissioner for Employment, Social Affairs, Skills and Labour Mobility will announce the winner (as a result of combined votes of the Jury and the on-line voting by the public)

3. Evaluation Committee

VET RESEARCH AWARD 2019

DIVERSITY and INCLUSION

PROPOSALS FOR THE VET RESEARCH AWARD 2019

The 4rd European Vocational Skills Week will be organised from 14 to 18 October 2019. As part of the Week, the European Commission will organise a VET Excellence Awards celebration.

This year's VET Research Award will showcase innovative VET research on diversity and inclusion.

The European Research Network in Vocational Education and Training (VETNET) has been appointed to manage the call for proposals and the nomination process. It invites VET researchers and other VET professionals to propose a researcher or a research team for the VET Research Award.

ELIGIBILITY

This award is open to any researcher with an outstanding research contribution in the field of diversity and inclusion in VET. Researchers must be nominated by another person. Self-nominations are not possible.

The award will be distributed to:

- a young researcher (up to age 35) or
- an experienced researcher or
- an intergenerational team of young and experienced researchers.

SUBMISSION PROCESS

All applications need to be submitted in English through the EUsurvey platform.

Information to be provided include:

Person proposing the researcher: Name, Address, Phone, Email

- Researcher(s) proposed for the award: Name, Affiliation, Address, Phone, Email, Website
- Research focus of the person /the team proposed for nomination. Description of her/his/their innovative work in VET research on diversity and inclusion. Min. 300 – max. 400 words
- Target group of the research (people surveyed): Initial VET, higher VET, continuing VET, careerlong professional learning, adult learning
- Visibility at the European, national and regional level, scientific soundness (e.g., transparency, adequacy, ethics), innovation (e.g., theory, methods and practice), and impact (e.g., on stakeholders, community, theory building)
- Main publications: List of most relevant publications and upload of sample publications in English. One of them must be peer-reviewed.

SELECTION PROCEDURE AND CRITERIA

A Selection Committee composed of international experts in VET research is set up and will nominate the best two candidates. If experts involved in the evaluation process are nominated, they will withdraw from the Committee.

Evaluation criteria: Overall contribution to research on diversity and inclusion in VET, Scientific soundness, innovation, impact, publications

There will be no correspondence on the proposals and the nominations between the proposers and the Selection Committee, unless the Selection Committee needs more information.

Nominees will be informed about their nomination by the chair of the Selection Committee. They will be invited to the Nominees Awards Celebration.

The final 2019 award winner will be selected through a mix of votes from the Committee, and the general public. The final result will be revealed during the Nominees Awards Celebration.
